What is a CWOF?

Remember this always: you are innocent until proven guilty. In Massachusetts, a not guilty plea is entered automatically on your behalf. Only two ways to change that. First, you're found guilty by a judge or a jury at trial. Or second, you voluntarily change your plea from not guilty to guilty. A guilty is no good because it's conviction. Now you have a record. One potential way around that is to use a tool called a Continuance Without a Finding (CWOF). Your not guilty plea does not change. You admit to the court that the facts known to the Commonwealth are enough to convict you, but you don't admit guilt. The case is literally continued without a finding of guilt. After a period of time (probation), the case gets dismissed, and you don't have a conviction. This usually needs to be negotiated with the prosecutor and at all times blessed by the judge.
